CIRCULAR

Sub: Reporting of Discrepancies in Theory Examination Question Papers within 10 (Ten) days from the date of the respective theory examination – Reg.

With reference to the subject cited above, I am directed to inform that any discrepancy observed in the theory examination question papers shall be reported to the University by the concerned stakeholders within 10 (Ten) days from the date of the respective theory examination.

It has been observed that some colleges have been submitting representations regarding discrepancies in the theory examination question papers even after the declaration of results and in certain cases, even after the lapse of more than one month from the date of the examination. Such belated representations cause avoidable administrative difficulties, delay the examination process and impede the timely disposal of grievances.

In view of the above, all stakeholders are hereby directed to ensure that any discrepancy in the theory examination question papers is brought to the notice of the University within the stipulated period of 10 (Ten) days from the date of the respective theory examination. No representation, complaint, request or correspondence received after the expiry of the stipulated period shall be entertained or considered under any circumstances irrespective of the reasons cited. No request for condonation of delay shall be accepted.

All Directors/Deans/Principals shall ensure that this Circular is brought to the notice of all Heads of Departments, Faculty Members, Examination Coordinators, and other concerned stakeholders immediately. They shall also ensure strict compliance with these instructions.

This Circular shall come into force with immediate effect and shall apply to all ongoing & forthcoming Theory Examinations.
